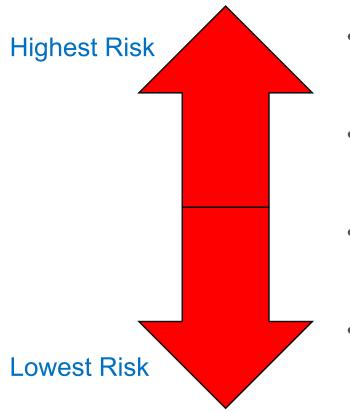

Pool Management Recommendations

Considering Safety Risk (liability):



- Unsupervised.
- Small operator or Community Group.
- MCC staff pool management
- Contract pool management to specialist operator.
 ie. YMCA, Belgravia, BlueFit

Pool Management Recommendations:

- Gloucester continue to manage with MCC casual staff.
- Stroud / Bulahdelah / Nabiac / Tea Gardens / Wingham move to management by "community group or small operator".
- Krambach close pool.
- MALC & GLAC remain with specialist contract management (retender).

Other Generic Recommendations:

- Reduce operating hours meet users demand period whilst reducing staff costs.
- 2. Maximise Learn to Swim (LTS) return incentivise group lessons over 1on1.
- Provide opportunity for local operators to provide flexible service ie. extend hours as required, allow group bookings out of open hours, offer LTS and canteen to suit needs.
- Seek funding opportunities for energy efficiency gains ie. heat pumps, variable speed pumps, solar electricity.
- 5. Invest in facilities to assist attraction value of aquatic centres.

Pool rationalising:

Krambach swimming pool

This swimming pool is not commercial standard and doesn't meet RLSS GSPO guidelines for water turnover and chemical dosing and electrical upgrade with future filter upgrades required. Given the operational risk, the cost to bring to an appropriate standard, the low patronage and the proximity to Nabiac, the recommendation is to close the pool and convert the space to a multisport court.

Wingham Memorial swimming pool

This swimming pool is showing its age and presents in a poor asset state. It leaks at the expansion joint where the pool was extended and through the gutters that are experiencing concrete cancer. The filtration system does not meet current guidelines and would require an initial cost of \$285,000 to separate the toddler pool from the 50m pool and further upgrade of the 50m pool plant and plant room in line with consultant's report of \$835,000 to bring it to standard.

Given increasing maintenance costs, water quality risks due to filtration, and its proximity to Manning Aquatic Centre, it is recommended that this pool is managed without significant investment until such time that the risk or cost is too great, at which time the pool is closed.

Summary of recommendations:

For season 23/24:

- No changes to management method.
- Encourage small group learn to swim classes compared to 1on1.

For season 24/25:

- **Gloucester** continue to be MCC staffed with reduced opening hours potential \$160,000pa reduction in operating costs.
- **Stroud, Bulahdelah, Nabiac** to be managed by community group or small operator with reduced operating hours potential \$60,000pa cost penalty but reduced risk.
- **Krambach** to be closed potential \$24,000pa cost saving.
- **Tea Gardens, Wingham** to be managed by community group or small operator with reduced operating hours potential \$320,000pa cost saving.
- MALC, GLAC to be tendered for new pool management contract with MALC outdoor pool reduced opening hours potential \$40,000pa cost saving.

Estimated net saving = \$460,000pa.

Suggested Actions:

- Develop community consultation strategy.
- Report to Council recommendations and consultation strategy to go to community.
- Consult community including if hours are to be restricted, what are the preferred open hours.
- Report to Council.
- Adopt a direction / plan.
- Plan and implement agreed changes for 24/25 season.
