INTRODUCTION

In 2018, MidCoast Council made a commitment to become a child safe organisation. Part of this is the implementation of a Child Safe Action Plan. This plan provides a blueprint for staff and elected Councillors in ensuring our organisation is safe for children and that we are putting their interests at the core of our decision making.

After the introduction of the Child Safe Scheme in 2021, all Councils were required to develop and implement a Child Safe Action Plan.

The plan draws upon the 10 Child Safe Standards, as set out by the Royal Commission into Institutional Responses to Child Sexual Abuse in December 2017. Each year, we will measure our performance by how well we are meeting these standards or working towards meeting them.

The Child Safe Action Plan relates to Council facilities and programs, and does not extend to areas outside Council's influence, like schools, churches or other organisations or activities.

After the draft Action Plan was developed, we sought feedback from the general community as well as child-focused organisations.

The feedback will be considered in a final revision of the Action Plan, prior to its formal adoption by Council.

Our commitment is to become a child safe organisation.

The Child Safe Action Plan provides a blueprint for staff and Councillors to make sure our organisation is safe for children and that their interests are always considered in the decisions we make.

The Action Plan outlines actions we will take to ensure we meet the 10 standards which form the basis of new legislation under the NSW Child Safe Scheme. We will report annually on progress on these actions.

The Action Plan applies to all Council facilities and programs.

This consultation:

- sought your feedback to review the Action Plan
- focussed on the actions included in the Action Plan and the indicators of success.

Your feedback will help us finalise the Action Plan, prior to its adoption by Council.

What's next

We're now preparing a detailed Engagement Outcomes Report that will include all your feedback.

It will be available soon.

SUMMARY AND NEXT STEPS

The draft Child Safe Action Plan was developed due to a commitment by Council and is the first step in ensuring Council is child safe.

The purpose of the engagement was to give the community, Council, Councillors and key stakeholders an opportunity to review the draft Action Plan and provide feedback. The engagement process also raised awareness of the plan and its relationship to the Child Safe Standards.

Overall, respondents felt the draft Child Safe Action Plan was a positive step; however, they commented on the need for better reporting and evaluation measures.

Seven people provided submissions. Sentiment about the Action Plan was mixed and included comments on what respondents thought was positive as well as suggestions for strengthening and improvement.

The key suggestions for improving the Action Plan included:

- strengthen the reporting and evaluation measures
- improve inclusivity and diversity
- simplify the document format

While the number of contributions were limited, the overall reach to the community was good and contributed to building awareness of the Child Safe Action Plan and its purpose.

This feedback will be considered by Council's community development team in their revision of the draft Action Plan. Responses to the issues raised will be documented as a part of a report to Council.



METHODOLOGY SUMMARY

The draft Child Safe Action Plan was placed on exhibition for 28 working days as well as a four-week period in December-January as specified in the Community Participation Plan.








In accordance with the principles in the Community Participation Plan, we aimed to engage with a wide variety of people in the community.

Key stakeholders targeted in the engagement included:

- Child-centred community organisations
- Schools and preschools
- Parents and carers of children
- Parents and carers of Aboriginal children
- Parents and carers of children living with disability
- Migrant families
- Council employees
- Councillors
- State agencies, including NSW Department of Communities and Justice
- YMCA – Manning and Great Lakes
- Sporting associations who use Council facilities
- NSW Surf Lifesaving – Mid-North Coast branch
- MidCoast residents

To get the word out, a range of strategies were used, including digital media, traditional media and direct communication with key stakeholders.

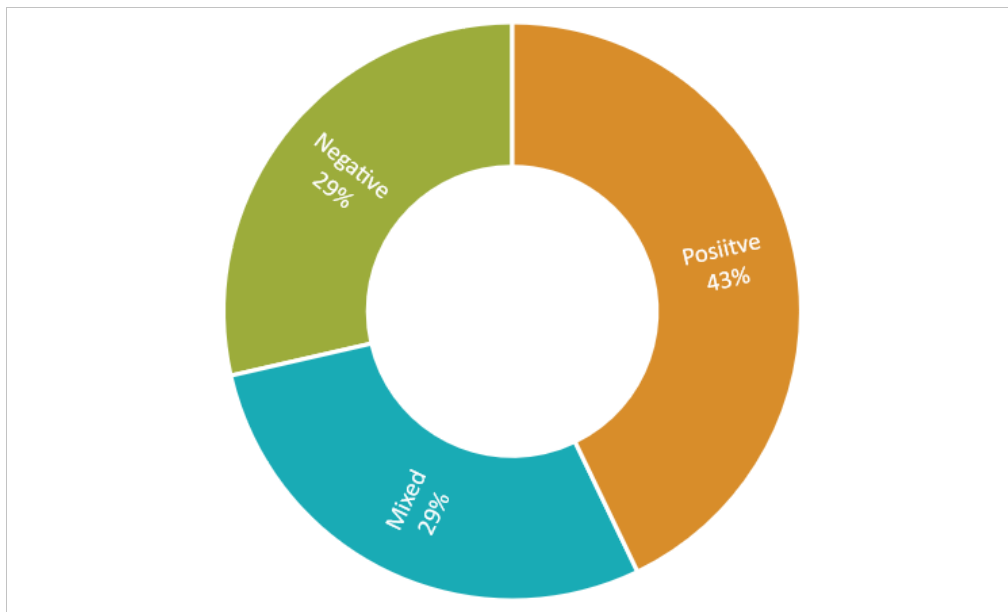

DETAILED DATA

Sentiment

Across the seven submissions, each was analysed to generate a general sentiment towards the draft Child Safe Action Plan. Those which contained neither positive nor negative comments, focusing on opportunities for improvement, were allocated to mixed. The distribution of sentiment is shown in the image below:



Themes

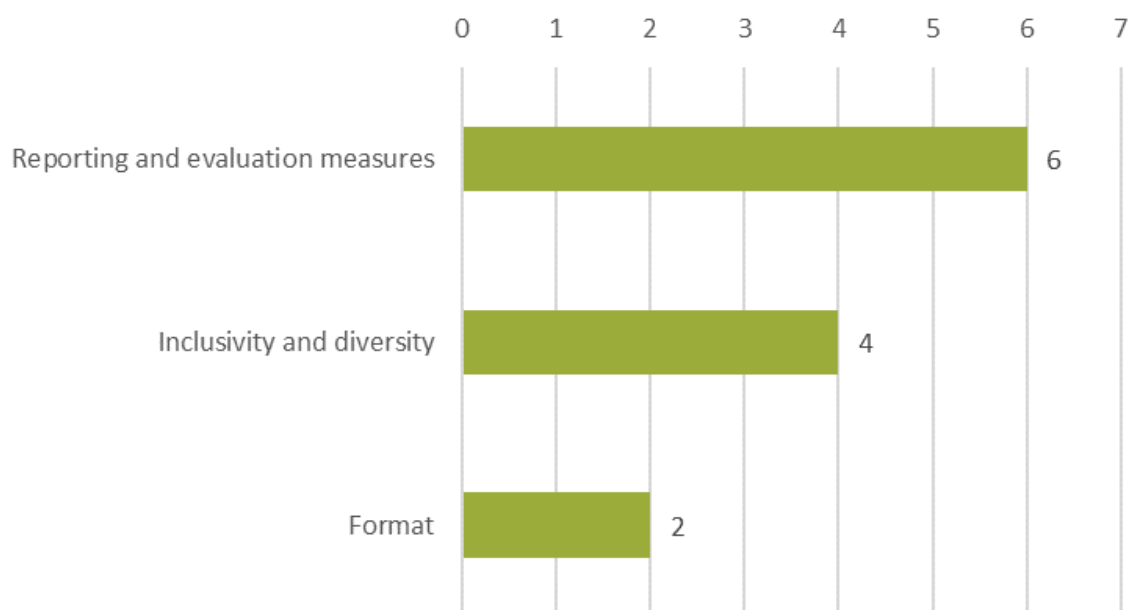
Overall, there was support for the Action Plan, especially the commitment by Council to be child safe. Feedback also highlighted the comprehensive nature of the Action Plan and the whole of Council approach taken.

Opportunities for improvement centred on three areas:

- Strengthen reporting and evaluation measures
- Inclusivity and diversity
- Simplify the document format



More than one issue could be raised within a submission. The breakdown of these areas for improvement are shown in the graph below:



The following table provides a detailed summary of the feedback on areas for improvement.

Format

Simplification of document. Utilisation of plain English. Layout could be improved through the utilisation of more headings with lead-in introductory sentence

Create a simple one-page version for children

Imagery is good

In addition to the comments received, 155 people visited the draft Child Safe Action Plan – Have Your Say page. While it is recognised that there are numerous reasons why individuals may not make a comment, this could be an indication there are a number of people who, while aware of the document, didn't feel it necessary to make a comment.

Overall the document demonstrates Council's commitment to child safe principles and practice.

Is there anything in the draft plan you really like?

That the document takes a whole of organisation approach and does not limit the scope of these requirements to child serving business units within Council. That Council is making a commitment to support community groups and organisations more broadly to meet child safe standards.

Is there anything missing from the draft plan that you'd like included?

Under Standard 1 - An indicator of success is: 'Children feel safer knowing they have input into the organisation', if this is the case, under actions, there should be some reference for the development of mechanisms for the participation of children. Perhaps this indicator belongs under Standard 2?

Under Standard 3 - It mentions that Council is committed to running information sessions etc. for community groups but there is no indicator of success. An indicator of success might be: 'Community groups and organisations across the Mid Coast demonstrate an understanding of Child and Youth Safe Standards and Principles and are confident in applying same'.

A note on this, Council should identify child and family service providers who are expert in and / or are funded to deliver such training to improve engagement e.g. Mission Australia

(Communities for Children); Blue Sky Community Services; NSW Ombudsman etc.

Under Standard 4 - There is no mention of CALD groups? With an increasingly diverse population, have Council considered there might be a need for things such as CALD competency training amongst staff who work with children and families; information available in other languages for certain community groups etc?

Standard 8 - ' Incorporate child safe design into public spaces'. This is an important action in keeping children safe in a broader community sense, but as an action, this statement is too vague. How does Council incorporate child safe design? What mechanisms are in place to ensure this is canvassed in all social planning / design activities? Is a best practice process in place?

How will Council monitor the implementation of the actions and measure its progress against the nominated indicators? Will staff be required to report to progress to Council at certain intervals? Can an evaluation plan be included in the document to ensure accountability?

Please provide any final comments:

Council has an additional role to play when it comes to child safety and building a child friendly community. I refer you to the UNICEF Child Friendly Cities and Communities Handbook.
